

Disciplinary Actions

The information in this section is intended to provide public notice of disciplinary actions taken by the New Mexico Department of Health and the Emergency Medical Systems Bureau.

Note that there may be various actions that are still in process, but have not yet been completed due to the administrative process.

Approximately 8000 EMT's and EMD's are licensed in New Mexico. Many EMT's share the same names. The listing of disciplinary / enforcement actions should be read carefully for names and unique license numbers. Only suspensions and revocations of EMS licensure are posted.

ALL POSTINGS WILL REMAIN FOR TWO YEARS AFTER FINAL ACTION IS TAKEN.
